## Fullcast Group obtains the 1<sup>st</sup> ISMS certification in the blue-collar worker dispatching segment

 The international standards-compliant management system introduced to protect personal information

Fullcast Co., Ltd. (based in Tokyo's Shibuya Ward; headed by President Takehito Hirano) and Fullcast Factory Co., Ltd. (based in Tokyo's Shibuya Ward; headed by President Takahiro Ishikawa), core companies of the Fullcast Group, a provider of comprehensive human resources outsourcing solutions, obtained the first unified certification of the international standard for the information security management system BS7799-2:2002(\*1) and the Japanese standard ISMS Certification Criteria Ver. 2.0 (\*2) as of June 27, 2005 as a company dispatching blue-collar workers to production lines or the logistics field in Japan.

Under the Personal Information Protection Law, which has taken effect since April this year, acquisition of the privacy logo is increasingly common in society. Whereas, this privacy logo is confined to the management of personal information assets, ISMS is a standard for the management of all information assets, including not only personal information, but information needed to conduct business as well. We have obtained the international ISMS certification on grounds that we should protect the entire scope of information assets.

Along with the ISO9001 certification (for the quality management system) acquired by the Fullcast Group (\*4), we intend to strive to step up corporate compliance and risk management, while promoting efforts to acquire the ISMS certification at all our business offices with the aim of continuing to improve the reliability and quality of our services.

## \*1 BS7799-2:2002

An international standard for the information security management system targeted at corporations and organizations set by The United Kingdom Accreditation Service (UKAS). Along with BS7799-1, which sets forth guidelines on implementation, this spells out specifications for the information security management system, serving as guidelines for obtaining the certification.

## \*2 ISMS Certification Criteria Ver. 2.0

The conformity assessment program concerning the information security management system. Japan Information Processing Development Corporation (JIPDEC) has drawn up this based on BS7799, and started full-scale implementation since April 2002. ISMS Certification Criteria Ver. 2.0 was formulated in April 2003 based on BS7799-2:2002.
