Notice of Change of Representative Director

Fullcast Holdings Co., Ltd. reached a decision at the board of directors meeting held on December 19, 2013 to change representative directors as follows.

1. Reason for the Change of Representative Director

Fullcast Holdings Co., Ltd. successfully returned to profitability in the fiscal year ended September 2010, after seeing continued losses since the fiscal year ended 2007, through personnel reductions, office consolidation, business restructuring efforts mainly consisting of the rebuilding of operational foundations, and financial restructuring efforts mainly consisting of sales of subsidiaries and real estate holdings, which were implemented in response to orders issued to its subsidiary Fullcast Co., Ltd. on October 3, 2008 to suspend its worker dispatching business and to improve its worker dispatching operations. The Company has also been striving to fortify the foundations of its part-time worker placement and part-time worker payroll management services, which were launched as the Company transformed its mainstay short-term human resources dispatching business into new services that respond to the implementation of the Revised Worker Dispatching Act on October 1, 2012.

The resigning President, Representative Director and CEO Hiroyuki Tokiwa has led the Company in these business and financial restructuring efforts and the launch of new services after he joined the Company as director in September 2008. For the next fiscal year, as the launch of new services has achieved tangible results, the Company has decided to pursue further growth of its business under the new management of Kazuki Sakamaki, who will be promoted internally as the new President, Representative Director and CEO.
