This company will provide staffing services (dispatching and placement) mainly for foreign nationals in order to provide diverse employment opportunities which anyone can work with peace of mind, under the corporate philosophy of "Providing the best place for people to bring out their best."

■ Helping to Eliminate Worker Shortages by Creating Employment Opportunities for Foreign Nationals

The growing seriousness of Japan's aging population and declining birthrate has led to worker shortages throughout the country. As a result, many companies today are faced with the difficult task of finding the human resources needed to power their businesses. Given this situation, the Government of Japan has announced a plan to promote the utilization of foreign workers. The number of foreign workers in Japan reached approximately 1.28 million in 2017, which marks an 18% increase over the previous year^{*1}. The Fullcast Group currently has approximately 4,000 foreign nationals registered as staff (foreign nationals with a status of residence in Japan). It is predicted that the number of foreign nationals looking to work in Japan will continue to increase.

However, companies have yet to fully develop systems to accommodate these workers. Many companies have yet to actively embrace the hiring of foreign national workers because of a lack of information on employment procedures or how to confirm visa status and general concerns over the living habits and communicating with people of different cultures.

To connect the rising number of foreign nationals looking to work in Japan with companies facing worker shortages, the Fullcast Group will harness its various know-how in hiring and employment to create employment opportunities for foreign nationals and respond to the needs of companies with worker shortages by developing appropriate working conditions and employment environment for foreign national workers, carrying out pre-checks of Japanese language proficiency for work, and offering aftercare support post-hire so as to alleviate concerns of both sides.

Going forward, the Fullcast Group will continue to deliver high value-added services through its support of human resource utilization that forms the foundation of all industries and to make efforts to contribute to society.
